## 3. LABORATORY TESTING

Our partner laboratories test your products on the basis of the respective certification program and using state-of-the-art procedures.

## 4. CONFORMITY ASSESSMENT

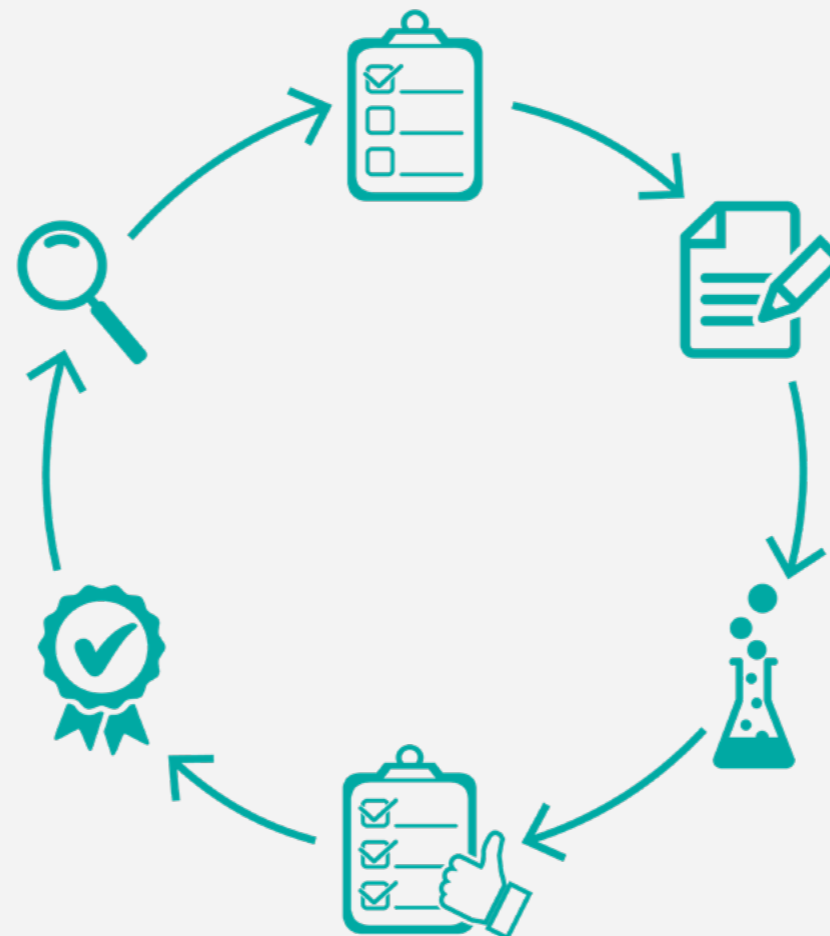
If the test is passed successfully, it's results are subjected to a conformity assessment by our certification partner.
